KCM Resale stores offer donated, gently used merchandise at a reasonable price to the community. Stores also accept vouchers issued by KCM Social Services and KCM Crisis Center to clients in need.

KCM Crisis Center provides emergency financial assistance and/or advocacy to victims of domestic or sexual abuse. The Center also provides education to individuals and groups concerning these issues. Katy Christian Ministries obtains the majority of items distributed through its food pantry from the Houston Food Bank and local grocery stores. Prior to January 1, 2014, KCM did not report the fair value of donated food as contribution revenue and food pantry expense as required by generally accepted accounting principles (GAAP). Effective January 1, 2014, KCM changed its method of accounting to report these donations at fair value as required by GAAP.

KCM services are offered to everyone in our community regardless of any religious background or affiliation.
